- 6. The College/Institute will follow the <u>R.6064</u> mentioned in the Circular No. UG83 dated 12th March, 2009.

You are, therefore, requested to submit the necessary indertaking stating that your college will fulfill the above conditions.

The admissions to these shall be granted on the recommendation of the committee, which will have a representative of the University of Mumbai. The admission process shall be communicated to the University of Mumbai.
- c) The facility at the Institute / Center shall be made available to the other students of the University of Mumbai.
- d) The Institute / Center shall provide stipend to the students enrolled / registered.
- e) The Institute / Center shall provide one month summer training to post graduates students of the University of Mumbai.
- f) One UV- Visible Spectrophotometer (200-1100 nm) should be

The above recommendations were accepted in Academic Council at its meeting held on 6th June 2012, vide item no 6.5.
