**1 FIXED ASSETS**

During the year Fixed Assets are recorded as Net of Gross value and accumulated depreciation till 31-03-2025. For this purpose Written down value of the asset as on 31-03-2023 is considered as Gross Value as on 01-04-2024 and Depreciation charged for FY 2023-24 is considered as accumulated depreciation as on 01-04-2024.

**2 DEPRECIATION**

Depreciation is charged under the written down value method.

**3 METHOD OF ACCOUNTING**

The accounts of the College are maintained on cash basis.

**4 GOVERNMENT GRANTS**

a) The grants receivd from State Government for recurring expenditure are accounted for as income in the year of the receipt.

b) The Grants received from University Grants Commission (UGC) and other agencies for Capital Expenditure, research activities and upgradation of assets are reflected in the Balance Sheet as "Grant Fund". The depreciation on the assets acquired out of such grants was charged to Income & Expenditure A/c upto FY 2015-16.

However w.e.f. F Y 2016-17 the depreciation on Fixed Assets acquired out of such grants is reduced from the respective grant a/c in Schedule of Grant Fund. The amount of Grant for capital expenditure as reduced by the amount of accumulated depreciation is now reflected in Schedule 1 attached to Balance Sheet.

**5 Investments**

In accordance with the practice consistantly followed , the trust discloses balance in Fixed Deposits with banks as Investments which are carried at cost and interest reinvested in certain cases.

**6 Inventory**

Inventories of Journals, prospectus and chemicals are valued on First in First out ( FIFO ) basis at cost.
