3. Section 22(1) of the M.P.T. Act prescribes the trustee shall report the change occurs in the entries of register kept u/s 17 to the Deputy or Assistant Charity Commissioner in charge of the Public Trust Registration Office within 90 days.

4. According to the aforesaid requirement, the applicant must file the application within 90 days of the change in the trust. However, the current application was filed after the limitation period has expired. However, Proviso of Section 22(1) provides that if there are satisfactory reasons for the delay, it may be considered. As a result, the grounds stated on the delay application are deemed satisfactory. As a result, application was allowed.

5. On perusal of notice of meeting it reveals that, on 20/09/2024 members and office bearers in managing committee meeting discussed and decided to change the articles of constitution of the trust and created the new post as Manad President in managing committee. Again, discussed and confirmed change in the articles of

Any person above age of 18 years, and with eminent and extra ordinary achievements in the field of Social, Education, Cultural, Political, Sports, and Science & Technology or any other field of work can be included by the Managing Committee of The Society, as an honor conferred on him or her, without any financial contribution, towards membership, and without any voting rights, irrespective of place of residence.

Current President will be the permanent managing committee member till he or she is alive hence the post will be excluded for the election.

ii) Managing Committee, comprising of and aggregating to seven members (excluding Founder and Honorary President) shall be elected through one electoral process, with separate designated posts, mentioned herein above.

v) The first board of trustees shall be seven (excluding Founder and Honorary President), and the strength of Managing Committee shall not be less than seven and more than nine at any point of time, in case, such strength reduces below such number then within 30 days of the period, it shall be restored back to minimum requirement.

i) Annual General Body Meeting shall be called once in the official year, by the Secretary of The Society upon giving notice with specific agenda mentioned therein.

ii) All General Body Meetings other than Annual General Body Meeting shall be termed as Extra Ordinary General Body Meetings or Special General Body Meetings, and may be called, by either of the two of President and General

Secretary of The Society, whenever think fit, giving notice with specific agenda mentioned therein.

iii) Notice period of meetings

Special General Body Meeting 14 days

Managing Committee meeting 5 days

Minimum of four number of meetings of Managing Committee members within a year shall be taken in any mode online or offline.

Minimum one number of AGM shall be taken in one official year.

iv) The notice regarding Managing Committee/ General Body meeting shall be circulated through digital media and in case of any member requesting for hard copy of the same shall be complied with.

v) The proceeding of the Managing Committee / General Body Meeting shall be in English or in Marathi.

vi) No discussions shall be proceeded at any General Body meetings unless a quorum of 2/3rd members is present at the time when the meeting proceeds to further discussions.

vii) In case of unavailability of quorum, meeting shall be adjourned for half an hour and shall be called after half an hour at same place and same day, and such adjourned meeting shall proceed to discussions, without condition of quorum availability.

viii) The Current President of The Society shall preside as Chairperson at every General Body meeting, in case however, current President is unavailable the General Secretary, and the Joint Secretary, in the same priority order, shall preside over the meeting.

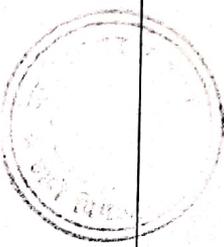

Founder President shall be the life member. And after him the President's post shall be given to his family members. Therein the next president will

automatically be the life member of the Society. It Shall be continued in the same pattern.

Duties of Office Bearers:

a) Functions of The President

i) The current President shall preside over all General Body meetings, Managing Committee meetings.

ii) The current President is empowered to sanction or spend such money, as it considers necessary on the promotion, maintenance and the upkeep of the Society, under exceptional circumstances and get ratified from Managing Committee meeting and General Body meeting as the case may be.

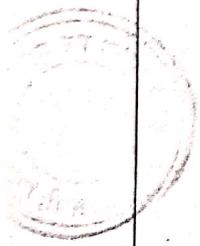

i) The Treasurer shall maintain all books for Accounts of The Society and shall receive all the money on account/behalf of The Society.

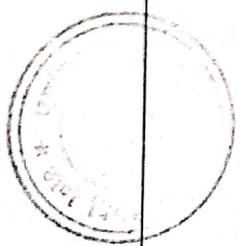
